The 2018 scholarship will be in the amount of  
**\$1,000.00**

Established by his union family to honor the memory of Michael E. Shampine, this fund is designed to provide a scholarship to an affiliated union member, or an immediate family member, who plans to enroll in continuing education.

The scholarship will assist with enrollment in a degree program, qualified trades apprenticeship, or vocational school. The ideal recipient will be recognized as having a desire to succeed by demonstrating strengths in leadership, community and political awareness.

**Eligibility:** Any graduate of a 4-year high school that is a union member or related to a union member who is affiliated with Decatur Trades & Labor Assembly, AFL-CIO. Eligible applicants include: union member, spouse, child or legal guardianship.

**Application Process:** Application shall be filled out and submitted by March 30, 2018. The applicant will be required to come in person for an interview on April 14, 2018 and will be required to write a short (one page) handwritten essay at the time of the interview. The essay topic will be around the following subject: "How does the labor movement affect the community in which I live?" The ideal recipient will be recognized as having a desire to succeed by demonstrating strengths in leadership, community involvement and political awareness.

**Selection Criteria:** Recipient will be determined based on application, interview and essay. Financial needs and high school grades are not considered. No limits on the number of applicants from each union.

**Notification / Recognition:** Applicants will be notified by May 1, 2018. Scholarship winner will be recognized in the annual Labor Day parade and requested to ride in a car provided by the central labor council. Scholarship will be paid to the educational institution.

## About the Michael E. Shampine Memorial Scholarship

Decatur Trades & Labor Assembly is currently accepting applications for the **2018 Michael E. Shampine Memorial Scholarship** for union families. This scholarship was created in honor of Shampine's outstanding service and commitment to the labor movement.

As president of our central labor council, Michael Shampine was a true visionary and believed that in order for our labor movement to grow we must continuously invest ourselves in our unions, our community and the political process. In honor of his service in Macon County, we are offering a \$1,000 scholarship to assist affiliated union members and their children in pursuit of their educational goals.

Michael E. Shampine was a 1969 graduate of Lakeview High School in Decatur, Illinois. After service in the United States Air Force, he began a career as a member of the United Union of Roofers, Waterproofers and Allied Workers, Local 92. In 1989, he was elected to the office of Business Agent / Financial Secretary for the Local and remained in that position until 2007.

In the year 2000, Mike was elected as President of Decatur Trades & Labor Assembly, a central labor council of the AFL-CIO. He was a strategic leader who worked tirelessly to lead the organization to new heights. Under his leadership the central labor council erected the Workers' Memorial Monument, hosted the Community Labor Celebration, and improved their political involvement to include more than 400 volunteers on Election Day.

He was active in community organizations such as United Way, Decatur Area Labor Management Committee, Decatur Building & Construction Trades, Decatur Dropout Task Force, Project Success, Decatur Housing Authority, and much more. He was appointed to many city boards involving labor and community development, served as precinct committeeman and ran for City Council in 2004. In December 2007, he was posthumously given Decatur Trades & Labor Assembly's Lifetime Achievement Award.

Shampine's loyalty and community participation set a high standard of conduct that served as an inspiration. The difference he made through involvement in the Decatur labor movement and community will be remembered for years to come.

Michael E. Shampine was born July 18, 1951 and died January 6, 2007.
