

Samuel Gompers said it best when he described labor's political mission nearly a century ago: "Stand faithfully by our friends and elect them; oppose our enemies and defeat them, whether they be candidates for President, for Congress, or other offices, whether executive, legislative or judicial."

Not words, but the record, is the measure of how we separate labor's allies from our adversaries. This voting record by no means covers all the issues that the Iowa Federation of Labor, AFL-CIO dealt with during the 2003 Legislative session. It does, however, record legislators' votes on a number of key issues of concern to union members and their families and will help Iowa trade unionists determine whether their elected representatives support labor's progressive agenda or have taken their stand with those who want to keep working people down.

Senate Issues – 2003

1. VOTING CHANGES

(HF 614)

Makes changes necessary to comply with the federal "Help America Vote Act," but would also make it more difficult for Iowans to vote by closing polls earlier, limiting absentee ballot use, and requiring a photo ID every time you vote.

IFL position was "NO."

Senate Vote: Passed 29 yes - 20 no

Vetoed by Governor

2. REGULATORY CHANGES

(SF 344)

Cuts Workers' Compensation benefits for twice-injured workers and makes it nearly impossible for consumers to win punitive damages in lawsuits over faulty products or dangerous behavior. Also restricts Unemployment Insurance eligiblity for workers; allows businesses to voluntarily self-audit for worker safety; prohibits the use of Project Labor Agreements on public works projects; prohibits the DNR from requiring permits for indoor air sources.

IFL position was "NO."

Senate Vote: Passed 26 yes - 24 no

Amended by House; portions incorporated into HF

692; item vetoed by Governor

3. PUBLIC EMPLOYEE COLLECTIVE BARGAINING

(SF 313)

Limits the scope of public sector bargaining and requires comparison of public employee compensation to that of both private sector and other public sector employees; eliminates arbitrator consideration of the power of the public employer to levy taxes and appropriate funds.

IFL position was "NO."

Senate Vote: Passed 26 yes - 22 no

Not considered by House

4. SCHOOL INFRASTRUCTURE FINANCE

(SF 445)

Establishes a school infrastructure financing program by providing for the sharing of revenues from local option sales taxes for school infrastructure purposes and allowing those revenues to be used for either school infrastructure or to replace property tax.

IFL position was "NO."

Senate Vote: Passed 33 yes - 17 no Passed by House; signed by Governor

5. UNEMPLOYMENT SURCHARGE

(S-3384 to SF 458)

Extends the Unemployment Surcharge paid by employers to fund rural Workforce Development offices

IFL position was "YES."

Senate Vote: Failed 21 yes - 28 no

Incorporated into HF 692; signed by Governor

6. GOVERNMENT REINVENTION

(SF 453)

Cuts \$128 million from the state budget, including \$70 million in cuts to local governments, \$20 million in cuts to AEAs, and \$10 million in cuts to child welfare; allows designation of charter agencies that will be exempt from certain rules and regulations in exchange for reducing their budgets by 10%.

IFL position was "NO."

Senate Vote: Passed 26 yes - 23 no Passed by House; signed by Governor

7. ECONOMIC DEVELOPMENT/ TAXES/REGULATION BILL

(HF 692)

Contains provisions for a \$503 million pay-as-yougo economic development fund, income tax cuts that shift more of the burden onto low-and middleincome taxpayers, and changes in business regulations that hurt workers and consumers.

IFL position was "NO."

Senate Vote: Passed 29 yes - 21 no

Item vetoed by Governor

8. PUNITIVE DAMAGES

(S-3394 to HF 692)

Strikes provision that eliminates consumers' ability to sue for punitive damages.

IFL position was "YES."

Senate Vote: Failed 23 yes - 27 no

9. WORKERS COMPENSATION

(S-3395 to HF 692)

Strikes provision that cuts workers' comp benefits for twice-injured workers.

IFL position was "YES."

Senate Vote: Failed 22 yes - 28 no

10. UTILITY SALES TAX

(S-3393 to HF 692)

Strikes a five-year delay of the utility tax phase-

IFL position was "YES."

Senate Vote: Failed 21 yes - 29 no

House Issues – 2003

1. VOTING CHANGES

(HF 614)

Makes changes necessary to comply with the federal "Help America Vote Act," but would also make it more difficult for Iowans to vote by closing polls earlier, limiting absentee ballot use, and requiring a photo ID every time you vote. IFL position was "NO."

House Vote: Passed 53 yes - 44 no Passed by Senate; vetoed by Governor

2. REGULATORY CHANGES

(SF 344)

Eliminates many anti-worker provisions passed in the Senate version, but still cuts Workers' Compensation benefits for twice-injured workers and makes it nearly impossible for consumers to win punitive damages in lawsuits over faulty products or dangerous behavior.

IFL position was "NO." House Vote: Passed 53 yes - 46 no Amended and incorporated into HF 692; item vetoed by Governor

3. SCHOOL INFRASTRUCTURE FINANCE (SF 445)

Establishes a school infrastructure financing program by providing for the sharing of revenues from local option sales taxes for school infrastructure purposes and allowing those revenues to be used for either school infrastructure or to replace property tax. IFL position was "NO."

House Vote: Passed 67 yes - 32 no Passed Senate; signed by Governor

4. UNEMPLOYMENT SURCHARGE

(H-1273 to SF 433)

Extends the Unemployment Surcharge paid by employers to fund rural Workforce Development offices and provides for long-term funding by setting up a reserve fund; expands eligibility for unemployment benefits.

IFL position was "YES."

House Vote: Failed 54 no - 44 yes

Portions incorporated into HF 692; signed by

Governor

5. SALES TAX ON FOUNDRY EQUIPMENT & MATERIALS

(HF 654)

Exempts sand handling equipment, core and mold making equipment, and materials used in the mold making process from sales and use taxes, providing refunds retroactive to July 1, 1997.

IFL position was "NO." House Vote: Passed 67 yes - 31 no Amended by Senate; signed by Governor

6. GOVERNMENT REINVENTION (SF 453)

Cuts \$128 million from the state budget, including \$70 million in cuts to local governments, \$20 million in cuts to AEAs, and \$10 million in cuts to child welfare; allows designation of charter agencies that will be exempt from certain rules and regulations in exchange for reducing their budgets by 10%. IFL position was "NO."

House Vote: Passed 51 yes - 47 no Passed Senate, signed by Governor

7. STATE INCOME TAX

(HF 701)

Cuts state income tax by a budget-breaking \$684 million with most of the benefit going to the wealthy; makes tax cuts contingent on passing a Constitutional Amendment requiring a 60% supermajority to raise taxes. IFL position was "NO."

House Vote: Passed 51 yes - 47 no Amended by Senate and incorporated into HF 692; item vetoed by Governor

8. PROPERTY & INCOME TAX/REGULATION/VALUES FUND **OMNIBUS**

(HF 692)

Contains provisions for a \$503 million pay-asyou-go economic development fund, income tax cuts that shift more of the burden onto low-and middle-income taxpayers, and changes in business regulations that hurt workers and consumers.

IFL position was "NO." House Vote: Passed 51 yes - 43 no Item vetoed by Governor
